#### CHAPTER-I

#### 1.0 INTRODUCTION:

In rural communities, the status of women is not effectually recognized. In some communities, they experience discriminatory treatment as compared to their male counterparts. They are deprived of certain rights and opportunities and are required to wholeheartedly dedicate themselves towards the implementation of household responsibilities. In the present existence, there have been implementation of programs and schemes that girls should be regarded as equal to men. Their birth should be appreciated and they should be allowed equal rights and opportunities, particularly with regards to acquisition of education and employment. Changes have come about in the viewpoints and perspectives of rural individuals and they are granting equal status to girls and women. Women in rural areas are not having proper facilities and education for their development. Most of the rural women have less access to health care. Women in villages are mostly house wife's and work in farm field for their livelihood.

Rural women's political participation and empowerment is not only essential for strengthening a nation's democracy, their struggle against marginalization, trivialization and oppression but also key to their socio-economic development. Rural women do not have the knowledge or awareness of their legal and political rights, so they do not participate in elections and political events of their communities. Rural women are underrepresented in institutions, governance and leadership, and have less decision making power. But women play important roles in the rural economy as farmers, wage earners and entrepreneurs. They also take responsibility for the well-being of the members of their families, including food provision and care for children and the elderly. Rural women's unpaid work, particularly in poor households, often includes collecting wood and water. Women from indigenous and grassroots communities are often also custodians of traditional knowledge, which is key for their communities' livelihoods, resilience and culture. Yet, women in rural areas face constraints in engaging in economic activities because of gender-based discrimination and social norms, disproportionate involvement in unpaid work, and unequal access to education, healthcare, property, and financial and other services.

#### 1.1 STATEMENT OF THE PROBLEM:

The present study encompasses a comparative study on Women status of kotemukha and Manikjore villages under Bhagawanpur-II Block in Purba Medinipur district in West Bengal. That is the statement of the problem. It tries to find out a comparative analysis between the status of women of two villages under Bhagawanpur-II block considering some economic, social and political factors.

### 1.2 Objectives of the study:

The main objectives of the present study are mentioned below.

- > The study aims to clarify the demographic characteristics of the study area.
- > To determine the relationship between economic condition and social status of women in study area.
- > To apprehend the education and health conditions of females in different age groups living in the study area.
- > To know the social and cultural participation of women.
- > To know about the political participation of women and to understand the role in the developmental process through political empowerment.

#### 1.3 Literature review:

- Ann. Rev. Anthropol. 1977. "ANTHROPOLOGICAL STUDIES ON WOMEN'S STATUS" in his research paper he shows that "women's status," in terms of female political participation, economic control, personal autonomy, interpersonal equality, legal adulthood, ideological position, or other specific indices, for the purpose of testing a particular hypothesis, they often lapse into much looser usage in nearing their conclusions, and speak broadly of "women's low status," "female subjugation," "female oppression," or "male dominance. Women in both low-skill wage labour and traditional work thus find themselves in oversupply, and in effect, suffer disguised unemployment.
- Heidi Blackburn (2017) "The Status of Women in STEM in Higher Education: A Review of the Literature 2007–2017" in his research paper he shows that This paper presents a thematic review of the literature regarding their status from 2007 to 2017 including journals, trade magazines, theses, and dissertations. Higher education is in the spotlight to produce graduates to fill the predicted 2.4 million STEM jobs anticipated by 2018 in the United States (Office of Science and Technology Policy 2016). This literature review is necessarily selective and focuses mainly on peer-reviewed journals and trade publications published between 2007 and 2017.
- ❖ Tim and Sinclair, Georgina (2013) "The status of women police officers: an international review" in his research paper The 1950s and '60s saw the beginnings of a gradual break out from this cloistered environment as women entered juvenile aid units and school traffic squads, eventually joining mixed patrol teams in the researchers conducted internet searches on police departments with English language websites, as well as searching government sites related to equity and public service management, up to July 2012e 1970s (Heidensohn, 1992). The police service has made substantial progress in the recruitment, representation and progression of female officers over the last 10 years.
- Maxwell Chuma, Department of Sociology Bernard Chazovachii,2012" DOMESTIC VIOLENCE ACT: OPPORTUNITIES AND CHALLENGES FOR WOMEN IN RURAL AREAS: THE CASE OF WARD 3, MWENEZI DISTRICT, ZIMBABWE "in his research paper The

major fulcrum of this study was on examining the impact of the Domestic Violence Act in reducing violence perpetrated against women. The study used qualitative methodology with unstructured interviews, key informant interviews and focus group discussions as the data gathering techniques. The study was grounded in Giddens' structuration theory which contends that structures and actors constitute each other.

Preston, J. P., Jakubiec, B. A., & Kooymans, R. (2013)." Common Challenges Faced by Rural Principals" Within this article, we thematically present common challenges associated with the role of the rural principal. In this literature review, we delimit our search to work published from 2003–2013. A limitation of this study is that it represents data predominantly from American, Canadian, and Australian rural settings, restricting a global applicability of results. Findings highlight that many rural principal candidates face a hiring disadvantage if they do not have a historical connection with the community advertising a position.

#### 1.4 DATA SOURCES AND METHODOLOGY:

#### \* DATA SOURCES:

This present study is basically descriptive in nature based on primary survey.

### • Primary data source:

This survey area is basically based on primary data source.

#### • SECONDARY DATA SOURCES:

Secondary data collect from different documents, census data, digital handbook, and from office.

#### **\* METHODOLOGY:**

### • House-Hold Survey:

We collect primary data through intensive door to door household survey with the help of structured questionnaire. To fulfill the objectives of the study, data on socio-economic factors (level of education, Occupation, income, etc.) were collected from women of both kotemukha and Manikjore villages.

#### Methods:

- 1. We have compiled all the primary and secondary data and tabulate the data to prepare master table. After that analyzed data for preparation of diagrams and subsequent analysis.
- 2. Statistical analysis has been done. We have drawn some cartograms by suitable cartographic techniques.
- 3. Map of Study area has been done by Arc- GIS 10.3 software. Land use Land cover map has been done from Google Earth Image.

# Population sample:

In this study area total households is 1225. Each of the village household survey is 25+25=50.

#### Tools used:

#### Ms. Excel:

Statistical data- some statistical diagram have shown to representing some basic data (after compilation) in order to make subsequent analysis for getting result. The diagram have been prepared with the help of Ms. Excel.

#### Arc GIS:

It is geographical information system (GIS) for working with maps and geographic information. It is used for creating and using maps, compiling geographic data, analysing mapped information, sharing and discovering geographic information, using maps and geographic information in a range of applications, and managing geographic information in a database.

### 1.5 Selection of the topic:

- Economically backward area and also political essentiative zone. So, to assess the social state case of women either through women in the economic condition. As well as the participation in politics or through political empowerment.

#### CHAPTER-II

### 2.0 Location of the study area:

According to census 2011 information the location code or village code of kotemukha village is 345242. Kotemukha village is located in Bhagawanpur II sub division of purba Medinipur district in west Bengal, India. Located at 87°67" N- 22°03"E. as per 2009 stats, Itaberia is the gram panchayet of Kotmukha village.

The total geographical area of village is 238.92 hectares. Kotmukha has a total population of 2061 peoples, out of which male population is 1105 while female population is 956. Literacy rate of kotmukha village is 82.48% out of which 86.97% males and 77.30% females are literate. There are are about 502 houses in kotmukha village. People living in kotmukha depend in multiple skills, total works are 810 out of which men are 683 and women are 127. Total 102 cultivators are depend on agriculture farming out of 99 are cultivated by men and 3 are women.

According to census 2011 information the code of Manikjore village is 345239. Manikjore village is located in Bhagawanpur II subdivisions of purba Medinipur district in West Bengal, India. Located at 21°94"N-87°68"E. As per 2009 stats, Basudevberia is the gram panchayet of Manikjore village.

The total geographical area of village is 222.03 hectares. Manikjore has a total population of 2979 peoples, out of which male population is 1499 while female population is 1480. Literacy rate of Manikjore village is 78.75% out of which 84.39%males and 73.04%females are literate. There are about 723 houses in Manikjore village.



# LOCATION MAP OF THE STUDY AREA

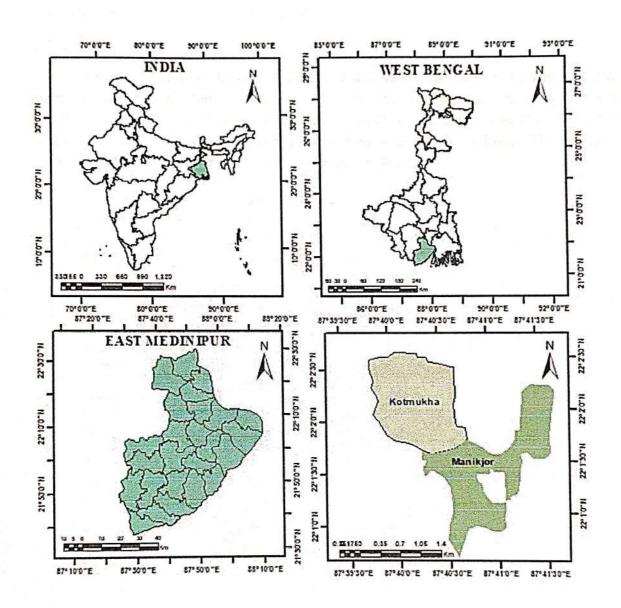


Fig: 2.1 Location Map of the study area

# 2.1 Physical setup of the study area:

#### 2.1.1 Relief:

Purba Medinipur district is the part of the lower Indo-Gang etic plain and Eastern coastal plains. Topographically the district can be divided into two parts-(a) almost entirely flat plains on the west, east and north, (b) the coastal plains on the south. The vast expanse of land is formed of alluvium and is composed of younger and coastal alluvial. The elevation of the district is within 10 meters above the mean sea level.

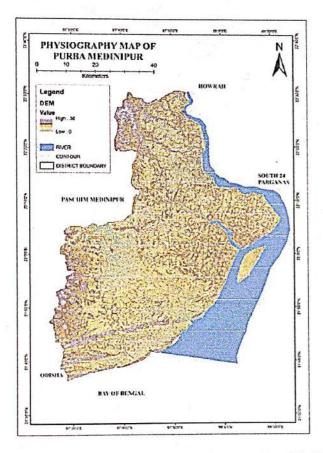


Fig No: 2.2 Topography Map of purba Medinipur district

### 2.1.2 Climate:

The districts of purba Medinipur yearly temperature is 30.52°c (86.94°F) and it is 4.55% higher than India's averages. Medinipur typically receives about 135.09 millimetres (5.32 inches) of precipitation. And has 136.0 rainy days (37.26% of the time) annually. Relative humidity is also very high.

### 2.1.3 Drainage:

The rivers of districts purba Medinipur, owing to the typical physiographical condition of the district, emerge from the chhotanagpur plateau to the west, flows east or south —East ward direction according to the slope of the land and meets Bay of Bengal. All the rivers in this region are rain — fed and flow to the fullest during monsoon.

The river system of district purba Medinipur primarily consists of Haldi River, Rasulpur River and Rup Narayan River their tributaries.

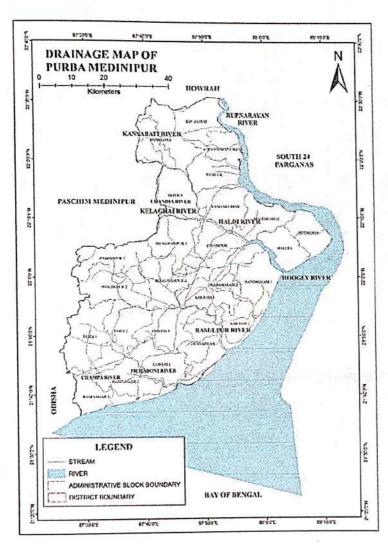


Fig No: 2.3 Drainage of purba Medinipur district

# 3.0 ANALYSIS OF DATA AND RESULT FINDINGS:

# 3.1 Demographic Background:

Demography is the statistical study of populations, especially humans. It examines and measures the aspects and dynamics of population; it can cover entire societies or groups defined by criteria such as education, nationality, religion, and ethnicity. Demographic information allows you to better understand certain background characteristics of an audience, whether it's their age, race, ethnicity, income, work situation, marital status, etc. in the context of human biological populations, demographic analysis uses administrative records to develop an independent estimate of the population.

### 3.1.1 Age composition:

In the population studies, age composition refers to the proportionate numbers of people in various age groups in a population. It is common in demography to split the population into three broad age groups: children and young adolescents (under 15 years old) the working age population (15-59 years) and the old age women (60 years and older).

The household survey data on age, reveals that 19.23% of female population in the villages of kotemukha and Manikjore in the range of 0-14 years. 58.65% of the female population in the Range of 15-59 years. And 22.12% belongs to old age groups i.e. above 59 years.

# ❖ Socio-economic status:

Socio-economic status is an economic and sociological combined total measure of a person's work experience and of an individual or families economic access to resources and social position in relation to others. When analysing a families SES, the households income, level of education, and pattern of occupation are examined, as well as combined income, where is for an individual's SES only their own attributes are assessed. Socio economic status is classified into three levels (high, Middle, and low) to describes the three places a family or an individuals may fall into. When placing a family or individual into one of this categories any or all of three variables (income, education and occupation) can be assessed.

Education in higher socio economic families is typically stressed as much more important, both within the households as well as the local community. In poorer areas, where food, shelters and safety are major priority, education is typically considered as less important.

Additionally, low income and education have been shown to be strong predictors of a range of physical and mental health problems, including respiratory viruses, arthritis, coronary disease, and schizophrenia. This problems may be due to environmental conditions in their work place, or, in the case of disabilities or mental illnesses, may be the entire cause of their person's social predicament to begin with.

#### 3.2 Social status:

The definition of **social status** is the position of an individual in a group or a society. This is defined by, and can also affect, how they are treated by other members of society. Analysing a group by the social status of its members can shed light on the intra-group dynamics. Social status affects all parts of life and the occurrences in communities of various types (religious, workplace, political, etc.)

#### 3.2.1 Level of Education:

According to field survey, a higher population in study area held a secondary education degree as their highest level of educational attainment compared with all other level of educational attainment. specially 19.23% of adult in study area had a higher secondary degree, compare with 17.31% of adult who have bachelor's degree and 11.54% of female had a post graduate degree or higher degree. Around 16.34% of female adult in both the study area had not completed high school.

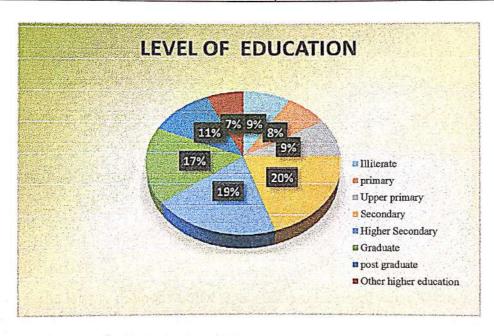


Fig No: 3.2 Level of education

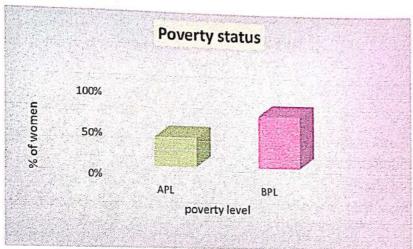




Fig No: 3.3 Poverty status

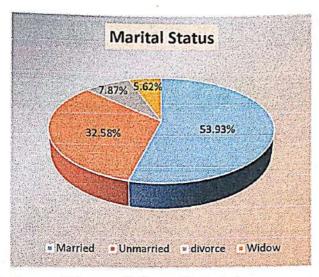


Fig no: 3.4 marital status

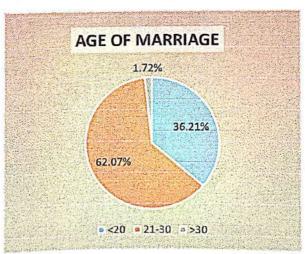


Fig No: 3.5 Age of Marriage

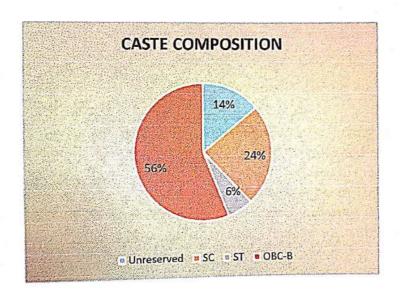


Fig No: 3.6 Caste composition

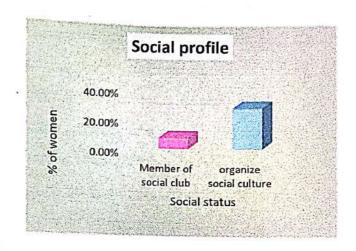


Fig No: 3.7 Social profile

# 3.3 Economic background:

# 3.3.1 Monthly family income of women's:

According to field survey, over 25% of families women's have a luxury standard of living and most of them belong to higher income cohorts (High-Middle and rich). Only 17.5% women's have an income of less than 5000 per month i.e., belongs to the aspiring or lowest income cohort. And most of the 57.5% women's have an income of 10,000-20,000. Also, the survey found that 82.95% of women's do some financial savings in the form of bank deposits, and insurance for their future. And they create their own identity, also they known about women's empowerment

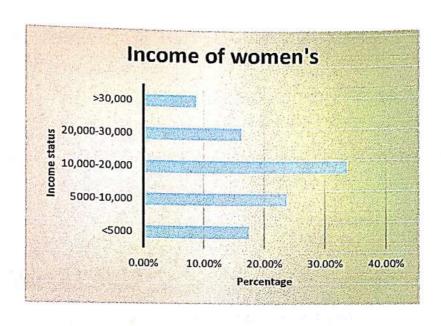


Fig No: 3.8 Income of women's

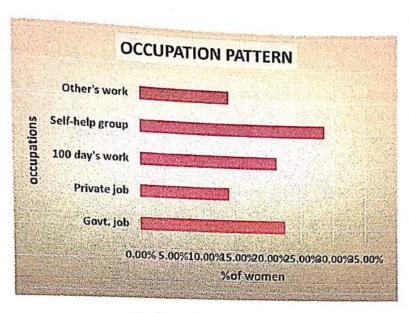


Fig No: 3.9 occupation pattern

#### 3.4 Medical factor:

Health facilities Are places that provide healthcare. They include hospitals, clinic, and output care centresetc. This includes affordability, restrictions on their mobility, and a lack access to transport, as well as mental and emotional well-being of rural women are needed in rural areas.

#### 3.4.1 Facilities from sub-centre:

Both the village's women's are given facilities from sub-centre (88%) during the time of mother and child care, safe delivery, family welfare services such as oral pills, primary medical care, Birth and Death Registration. But 12% of women ignore this facilities.

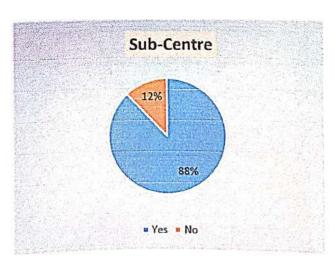


Fig No: 3.10 Facilities from sub-centre

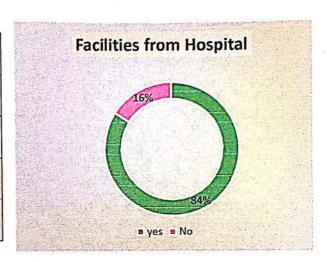


Fig No: 3.11 Facilities from Hospital

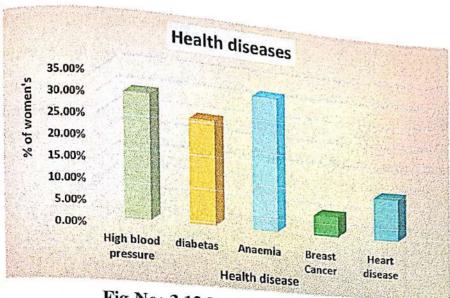


Fig No: 3.12 Health diseases

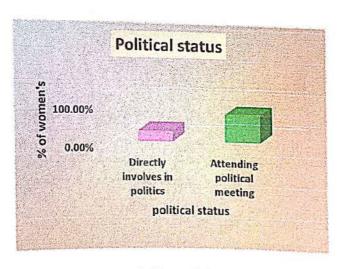


Fig No: 3.13 political status

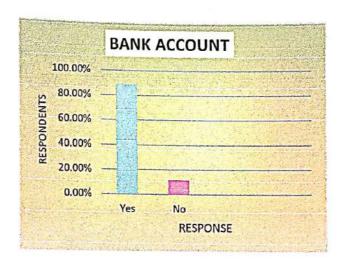


Fig No: 3.14 Bank Account

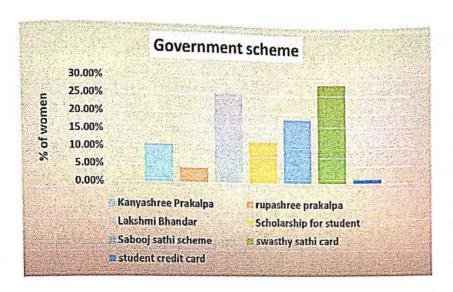


Fig No: 3.15 Government scheme

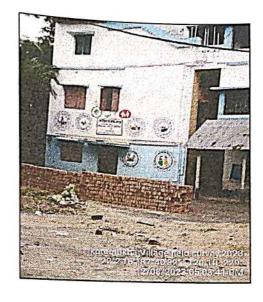


Photo Plate No: 1.3 Health Centre

# CHAPTER-IV

# 4.0 Major findings:

- 1. If we look into the relief of kotemukha and Manikjore villages under Bhagwanpur-II Block in purba Medinipur districts, that is the plain area.
- 2. The data on age composition reveals that the percentage of adult women is high (58.65%) and least amount of female belongs to child age group (19.23%).
- 3. Poverty status are also very high in this study area because 64% of women belongs in BPL card and reaming 36% of women is APL holder.
- 4. The survey data also indicate that most of the people are educated up to secondary (20.19%). While analysing the marital status 53.93% are married and 32.58% are unmarried.
- 5. This data shows that 63.79% of women are conscious about their marriage age and preferred delay marriage.
- 6. More than 80% of women accepted medical facilities from hospital and Sub-centre.

  And less than 20% of women ignore the medical facilities.
- 7. In this study area 31.55% of women are attacked by anaemia and 29.17% of women are suffering from high blood pressure disease. List amount of women's are suffered by breast cancer (4.76%).
- 8. 27.45% of women are directly involves in politics and 72.55% women are attending political meetings.
