Meeting started at 1.00 p.m. at IQAC Room, with Dr. Pijush Kanti Tripathi (Officer-in-Charge) in the chair. Dr. Debasish Banerjee attended the meeting through online mode.

- 1. The minutes of the last meeting dated 28/06/3023 read out and confirmed.
- 2. AQAR for the Session 22-23 placed to the IQAC and decided that after some necessary updation and modification it will be submission after Puja Vacation.
- 3. It was resolved that existing IQAC members will be allowed to continue till upcoming NAAC visit. Two members, one from Industry and one administrative officer may be included in IQAC and Dr. Tripathi (OIC) will take initiative for that.
- 4. It has been decided that for Institution Industry Collaboration our Officer-in-Charge will initiate the process.
- 5. For opening of Research Cell, Dr. Sudipta Pathak, Assistant Professor in Chemistry (W.B.E.S.) already defended our proposal at Vidyasagar University and University Officials informed to the Officer-in-Charge for inspection at the college soon.
- 6. For better understanding of 4-years degree course by 1st Semester Students it has been decided that One week workshop will be conducted Department wise for Major, Minor and Multidisciplinary Courses.
- 7. 6th Semester Result 2023 analysed departmentally as well as centrally. Out of 391 students who appeared for examination only 7 need to reappear for examination. Department noticed that the unsuccessful students did not follow the teachers advice regarding DSE subject choosing, which effected on their results. It is decided that from precautionary measures need to be taken from next session.
- 8. It has been decided that Parent-Teacher & Student-Teacher meeting for the Odd Semester students will be conducted immediately after Puja Vacation.
- 9. It has been decided that IIQA-SSR for 3rd NAAC cycle will be submitted by the end of November. IQAC Co-ordinator Dr. Sadhukhan will look after the matter.
- 10. For ragging free campus, Anti-Ragging Committee and Anti-Ragging squad have been formed committee convener will monitor on time to time hostel visit and counselling of hostel boards.

The meeting starts at 12.30 p.m. with Officer-in-Charge in the chair. Prof. (Dr.) Dipak Ranjan Mandal, Prof. Debnarayan Roy and other members were present in the meeting. At the onset of the meeting the IQAC coordinator read out the resolution of the last meeting held on 07/02/2024, and it was confirmed and accepted unanimously.

It has been resolved that the action on DVV process to be taken with due care under the supervision of NAAC coordinator. The workload on DVV compliance activities should be divided among the teachers and the compliance on queries to be uploaded carefully with stipulated time and this decision is implemented with immediate effect.

Regarding the fund for the payment of NAAC related fees [IIQA-Rs.29500/- + SSR (Rs. 118000/- + Rs. 118000/-)+ NAAC visit logistics Rs. 236000/-] Officer-in-Charge has already communicated with Higher Education Department and the fund has been sanctioned. Initially, before the sanction of fund Officer-in-Charge has paid the amount Rs.29500/- (IIQA) and Rs. 118000/- (during SSR submission) from other college funds which has been reimbursed later. Officer-in-Charge further requested to take initiatives for some more fund from Government for NAAC visit expenses.

It has been unanimously decided the college will start 2^{nd} semester classes from 6^{th} May-2024 after the completion of the 1^{st} semester final examination.

It has been resolved that the Parent-Teacher, Student-Teacher meeting to be conducted by the respective departments and Students feedback to be collected department wise within the Session 2023-24.

The IQAC coordinator are requested to take initiative to collect feedback from different stake holders for the session 2023-2024.

For reintroduction of TTM course Officer-in-Charge are requested to continue the communication with Higher Education Council.

For the impending visit by the Vidyasagar University for setting up a research cell at the college for the science faculties, the proposal for which has already been accepted by the University, so for the inspection process, the Convener and other members of the Research Committee are requested to initiate the process as per the communication made by the University.
